First tuition payment is due the first day of school and then the beginning of every month of service from August through May 2018 into 10 equal payments. There will be \$ 35 fee for returned checks. After the second returned check all payments must be made in cash.

To withdraw your child, you must provide 30-day written notification. You will be billed through the end of those 30 days. You will be responsible for the tuition during the 30- day notice, whether your child attends the school or not. \_\_\_\_\_

Failure by Parent/Guardian to pay any scheduled payment shall be deemed in breach of this contract and may result in termination of the student's enrollment. In the event that legal action is taken to collect delinquent accounts, Parent/Guardian agrees to pay all collection costs, including but not limited to: third-party collection fees, court costs, and attorney fees. \_\_\_\_\_
